<b>ADAR</b>	ADA Recovery	Present	Exempt	YES	NO	NOT FOR USE BY SCHOOL STAFF.Used by District Office ONLY for schools participating in Saturday School with approved District Partner
<b>ADMN</b>	Principal/Vice Principal	Present	Exempt	YES	NO	Student on campus with the school administration (Principal, VP) during school hours for an entire class period, NOT on suspension
<b>COLL</b>	College Visit	Present	Exempt	YES	NO	Used to document a school sponsored college/school visit supervised by certificated school personnel (Homeroom teacher supervises class to visit CSU campuses for one or more periods)
<b>COUN</b>	Counselor	Present	Exempt	YES	NO	Student on campus with School Counselor, private counselor or therapist, other mental/behavioral health on campus meeting, for an entire class period
<b>CSUS</b>	On Campus Suspension	Present	Exempt	YES	NO	On Campus Suspension is used with the behavior resolution: In House Suspension <u>ONLY ADMIN Assigned NOT TEACHER Assigned &gt; half a day</u>
<b>CVDR</b>	COVID POSITIVE	Absent	Excused	NO	YES	Used when student has tested positive for COVID. Must have positive test result: medical note, photo of result, screenshot, etc. Not to be used for exposure, symptoms only or any other COVID related absence.
<b>GOVT</b>	Government or Civic Activity	Absent	Excused	NO	YES	Engagement in a civic or political event: a civic or political event as including, but not limited to: · voting · poll working · strikes · public commenting · candidate speeches · political forums · civic forums · town halls. Student must provide notification to the school ahead of the absence.1 per student per year (Admin can approve more)
<b>GRAD</b>	Senior Activities	Absent	Exempt	YES	NO	SENIORS ONLY- To be used after graduation ceremony with approval from site Administrator to engage in graduation related activities
<b>HHC</b>	Home Hospital Complete	Present	Exempt	YES	NO	For Students in Assigned Home Hospital Program via Health Services Department. TBD via Health Services Staff who will contact each site to update student attendance. SPECIFIC INSTRUCTIONS TO FOLLOW FROM HEALTH SERVICES

<b>HLTH</b>	Health	Absent	Excused	NO	YES	EC 4610 and 48205: Illness: mental, physical or behavioral of the student, quarantine, exclusion for medical reasons or for the benefit of mental or behavioral health (proactive mental health day.) No positive COVID test. MAXIMUM of 10 per year then OTHR (11+ health related without medical note) or MEDV w/medical note.
<b>ISC</b>	Independent Study - Complete	Present	Exempt	YES	NO	Completed Work IS (Independent Study Only)
<b>ISN</b>	Independent Study - Incomplete	Absent	Unexcused	NO	NO	Incomplete Work IS (Independent Study Only)
<b>LATE</b>	Excused Tardy > 30 min	Tardy	Excused	YES	NO	Used for students who arrive 31 minutes or more after the school start time with verification from medical, dental, or other approvable provider or parent/guardian verifies the late arrival is due to reasons considered an excusable absence per Ed code Section 48205 - All Excused absences from school. Parents must verify (Funeral, Civic duties, religious event, etc.)
<b>MEDV</b>	Medical Verification	Absent	Excused	NO	YES	Absent with medical verification (Doctors note, Hospital check-in form, etc.)
<b>NATP</b>	Non-Attendance Period	Present	EXEMPT	YES	NO	Non-attendance period (PLACE HOLDER for creating Block Schedule for majority of student body ie. Finals, Testing, etc.) * Please Reconcile absences the following day see Quick Reference #003
<b>NURS</b>	Nurse	Present	Exempt	YES	NO	Student on campus with school nurse
<b>OTHR</b>	Other - Personal Unexcused	Absent	Unexcused	NO	YES	Used when parent/guardian verifies absence for unexcusable reason per Ed code 48205 {counts towards truancy} -going to work with parent, vacation, babysitting, personal problems, parties, shopping, parent illness, 11+ HLTH absence w/o medical note, any other reason that parent verifies, but is NOT included in Education Code sections 48205 as excusable)

<b>PERS</b>	Personal	Absent	Excused	NO	YES	Personal Absence– EC 48205- student’s court appearance (requires verification), funeral services (one day, in state, three days, out of state), cultural ceremony, parent’s employment conference (requires prior principal approval), student parent of child who is ill or has a medical appointment, observance of a religious holiday or ceremony, cultural event, spending time with family who is an active duty military, student's naturalization ceremony, or at the discretion of principal.
<b>SUS</b>	Suspension	Absent	Excused	NO	YES	Suspension – EC 48900-48925: Suspension absence is granted when school administrators suspend a student in order to improve his/her behavior, or for the protection of other students and or school
<b>SVST</b>	School Visit	Absent	Excused	NO	YES	Used when student visits a school campus other than their enrolled school (any grade level including college) with parent/guardian NOT School Staff (Verification Required: Note from School Staff, event flier, etc. (Parent takes 11th grade student to visit multiple colleges over 2 days)
<b>T&gt;30</b>	Tardy > 30 min	Tardy	Unexcused	YES	NO	Unexcused tardies – EC 48260: Tardies, in excess of 30 minutes, with or without verification from parent for reasons deemed unexcusable. 3 Unexcused tardies = 1 truant absence (examples: car troubles, over slept, traffic)
<b>TEST</b>	School Testing	Present	Exempt	YES	NO	To be used for on campus school testing when class schedule has not been altered for Testing. SAT, PSAT, SBAC, ASVAB, etc.
<b>TRDY</b>	Tardy < 30 min	Tardy	Excused	YES	NO	Used when a student arrives LESS than 30 minutes after class period start timeY
<b>TRNT</b>	Truant	Absent	Unexcused	NO	YES	Truant absence – Absent without consent or knowledge of the parent(s)/guardians(s). Must be verified by contacting parent/guardian and documented communication
<b>TSUS</b>	Teacher/Class Period Suspension	Present	Exempt	YES	NO	Used when the behavior resolution of Teacher/Class Suspension is assigned. When teacher NOT Administrator suspends student for period and student remains on campus

<b>UNV</b>	Unverified - Incomplete	Absent	Unexcused	NO	YES	Absences, which have NOT been verified by any means (contributes to Truancy).
<b>VP</b>	Verified Present	Present	Exempt	YES	NO	Verified Present: Student who has been verified present; used to clear out the attendance mark that was made in error - used in conjunction with the <u>Single Period Attendance</u> report ONLY
<b>VT</b>	Verified Tardy	Tardy	Excused	YES	NO	Verified Tardy: Student verified tardy - used in conjunction with the <u>Single Period Attendance</u> report ONLY
<b>WBLG</b>	Work Based Learning Guest Speaker	Absent	Exempt	YES	NO	Work Based Learning Only- Used to document a guest speaker work-based learning experience supervised by school personnel
<b>WBLI</b>	Work Based Learning Internship	Absent	Exempt	YES	NO	Work Based Learning Only-Used to document an internship work-based learning experience by school personnel
<b>WBLS</b>	Work Based Learning Job Shadow	Absent	Exempt	YES	NO	Work Based Learning Only-Used to document a job shadow work-based learning experience supervised by school personnel
<b>XTRA</b>	Extracurricular	Present	Exempt	YES	NO	School Related and Supervised Extracurricular Activity – (debate team, football game prep, field trips, other school related activity (counts as present) DO NOT USE FOR TESTING or SCHOOL VISITS see TEST or SVST
